The Committee

- Noted that the Personnel Committee awaits instructions for next steps. Also needs a Board liason.

Right Relations Committee

Need to establish a group to recommend to the Board both a policy and a mechanism for how conflicts could be resolved between ministers and staff, ministers/staff and congregants, and between congregants

Basecamp use

- Email sent to “board” or “president” should be answered only by the president > one-face policy.
